## RESOLUTION TO IMPOSE ONE PERCENT (1%) PROPERTY TAX ADMINISTRATION FEE

## I. Preliminary Recitals

THE TOWNSHIP BOARD OF THE TOWNSHIP OF BEDFORD, COUNTY OF MONROE, STATE OF MICHIGAN, STATES:

WHEREAS, the Township of Bedford is a general law township municipal corporation located in Monroe County, Michigan, which levies ad valorem taxes upon real property, collects tax levies, and handles review and appeal matters arising therefrom, and

WHEREAS, Michigan Public Act 503 of 1982 provides that a local tax collecting unit shall impose a property tax administration fee (commonly referred to as a "PTAF") of not more than one percent (1%) of the total tax bill per parcel to each tax bill, and

WHEREAS, it is the desire of the Township of Bedford to approve and authorize the imposition of a property tax administration fee pursuant to Michigan Public Act 503 of 1982 to offset the cost incurred in assessing property values, collecting tax levies and in the review and appeal process.

## II. Resolution

NOW THEREFORE, THE TOWNSHIP BOARD OF THE TOWNSHIP OF BEDFORD HEREBY RESOLVES AS FOLLOWS:

RESOLVED, that the Township Board of the Township of Bedford, Monroe County, Michigan, does hereby approve and authorize the imposition of a property tax administration fee of one percent (1%) to each total tax bill per parcel pursuant to Michigan Public Act 503 of 1982; and further

RESOLVED, that the one percent (1%) property tax administration fee shall be imposed on all property taxes and property tax equivalents, including, but not limited to, industrial facility taxes. However, the one percent (1%) property tax administration fee shall not be imposed on special assessments, fees for dangerous building demolition or blight cleanup, or for any other taxes or fees not permitted by Michigan Public Act 503 of 1982; and further

RESOLVED, that the property tax administration fee shall be collected and used in the manner and method set forth in Michigan Public Act 503 of 1982, as amended and as may be amended; and further

RESOLVED, that this Resolution shall apply to all property tax levies that shall become a lien on the property after the effective date of this Resolution, beginning with the summer 2009 tax collection; and further

RESOLVED, that this Resolution shall remain in full force and effect unless and until revoked or rescinded by Resolution of the Bedford Township Board.
